Brendan's concerns re operating an old facility with safety issues and Ron also the liability risks that the committee of management is exposed to if an incident involving a patron or employee injury were to happen? Do we need to put ourselves under this stress?

Also, our 2 best volunteers are in their 80's and we are not over run with young volunteers. Brendan moved: That we look at handing back management of the Pool, lifeguards and pool plant to council and keep BHPA involvement to Kiosk only. Second Hazen All in favour

Brendan will contact Neville Ivey to arrange a meeting during the day in the next week or two and will also hopefully involve Council Safety officer as well.

Peter—Plant report- Pumps are all operating well after some big leaf days. Brendan and Peter replaced the Chlorine injection line with new hose supplied by council.

Safety visit- pointed out some deficiencies with paint storage and signage plus a loose tray on the slide that were all attended to by Peter.

Side note Brendan – We were told of the visit by email with only one day notice with a copy of a comprehensive Safety Audit done on Nov 18th 2019. I sighted the notice and Audit on the morning of the Safety inspection. 3 months to get a report and the season is 2 weeks from being over is added frustration to where we would stand in a injury situation. Thankfully Peter and myself had rectified a lot of the faults but not all.
