Business arising from Treasurers Report: None *Other Business*:

Brendan — Pool update. BHPA members are not allowed to run any activities within pool grounds as we are not City of B employees. (Quote Gerald Dixon Aquatics manager) No feedback from letters so far re: what do we need to be allowed in the grounds dealing with public.

Brendan tabled "Aquatics Vic Report" for 2019-20.

Of note: Aquatic Centres had zero income for the last 3 months of the financial year and much the same could be assumed for July-Oct in 2020.

Approx 8000 training positions were cancelled (Lifeguard, Swim teach, First Aid etc) Our pool was closed on several hot days due to lack of Lifeguard Staff.

Donations totalling \$52 were received from families at Learn to Swim in appreciation of the work of the Milo Team.

History collection. Brendan has spoken to Roy Littlehayles and Marg Fisher re photo collecting. John will introduce Brendan to Marg McKenna in the near future also as another source of historical photos.

Andrew -- Post Office Update. 2 parties are known to be interested in taking on a Post Office. Both under discussion with Aust Post at the moment. Can BHPA drive a community response to help get a service established. In the next Newsletter? can we survey / measure the communities level of passion for the post office to return. Brendan and Hazen will work on wording a proper survey thru the Hub and promoted in the Newsletter
